1. Object of the Processing

The Data Controller processes personal data, i.e. "identifying" data - such as: first name, last name, company name and e-mail address, as well as special data - such as: data relating to health status, trade union membership, racial and ethnic origin, religious beliefs, political party membership, holding elected public office, etc.

2. Purposes of processing

3. Modalities of processing

4. Access to data

6. Nature of data provision and consequences of refusal to respond

7. Rights of the data subject

-to obtain, from the Data Controller or the Data Processor, without delay:

1) the confirmation of the existence of a processing of personal data concerning you and the communication in intelligible form of the same data and their origin, as well as and the purposes on which the processing is based;

2) the deletion of personal data concerning You, when: i) the data are no longer necessary in relation to the purposes for which they were collected, ii) You have revoked Your consent and there is no other legal basis for the processing, iii) the data have been processed in violation of the law, iv) You have objected to the processing and there is no overriding legitimate reason for the processing v) the controller is under a legal obligation to delete the personal data;

3) the updating, rectification or, if You are concerned, the integration of the data;

4) certification that the operations referred to in numbers 2) and 3) have been brought to the attention, also as regards their content, of those to whom the data were communicated or disseminated, except where this proves impossible or involves a manifestly disproportionate to the protected right;

- to object, on grounds relating to Your situation, to the processing of personal data concerning You, pursuant to Article 6(1)(e) or (f);

- to lodge a complaint with a supervisory authority;

The Controller shall provide You with a copy of the personal data being processed; in the event of requests for additional copies, the Controller may charge You a fee based on the actual administrative costs incurred.
